# HAPPY HOLIDAY SEASON

The 12th month -- The 12th Step -- The 12th Tradition --

The 12th month reminds us that it is the season to be jolly and giving and loving, which is Al-Anon's way for all seasons.

The 12th Step reminds us - " Having had a spiritual awakening as the result of these steps, we tried to carry the message to others and to practice these principles in all our affairs." The most important words to me in this step are " as the result of these steps", the other 11, for without the other 11 in my life I could not have had a spiritual awakening. Without the other 11 steps I would not have the principles to apply to all my affairs and if I did not have these principles, I would have no message to carry.

The 12th Tradition reminds us - " Anonymity is the Spiritual foundation of all our Traditions, ver reminding us to place principles above Personalties." Again the words, all our Traditions, and this one must be studied and deeply thought about to be understood and rightly applied. The word anonymity goes far beyond the simple idea of keeping the identity of members from exposure. It says, in effect, that the principles by which we find our help are of far greater importance than the individual who gives or receives that help. It implies, no matter who you are, or what your views, attitudes and wishes maybe, all this must be subordinated to the spiritual principles established for the greatest good of the greatest number. In this sense, we acknowledge ourselves to be anonymities, for principle is everything. Acceptence of this idea may come slowly to many of us: it requires real humility. In our fellowship no one need look far to find someone still in need. Lifting that person's spirits with a thoughtful word or a kind act is a small payment on ones own debt -- Don't count the hurts you have received but remember the kindnesses extended to you --- and repay them tenfold to anyone still in need. It is this ability to scatter blessings in recognition of blessings we ourselves have received, which makes us persons worth knowing and having as friends. Al-Anon's favorite Forum Editorials

# Our Sixth Concept of Service States:

The Conference acknowledges the Primary administrative responsibility of the trustees. We as individual groups do not have the ability to run the District or State Offices, so we turn the Authority over to people we elect, trusting them to do what's best for our Groups. Our G. R. and D. R. go to meetings at local levels where they turn over our ideas to the State Delegate; who in turn goes to the New York Conference where most of our ideas are voted on. These people are not the bankers, lawyers or business people that are needed to Administer the wide and varied range of affairs of World-wide public relations. They delegate our affairs of a board of trustees who are responsible for our service activities as well as Al-Anon's public relations. They are to watch over our Twelve Traditions, and only the trustees can evatuate and handle the unnumberable transactions in our World Service operation. In view of the responsibility they need to be given a large amount of Authority and leadership with which to discharge it. It should also be understood that the World Service is first a matter of policy and business; while our objectives are spiritual. These Aims can only be

achieved by an effective business operation. Since our trustees must function like directors of a large corporation they have to have ample Authority to manage and conduct Al-Anon's business.
