ARTICLES OF INCORPORATION  
OF

AL-ANON ALATEEN INFORMATION SERVICE CENTER, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is Al-Anon Alateen Information Service Center, Inc..

SECOND: The period of its duration is perpetual.

THIRD: The corporation is a non-profit corporation.

FOURTH: The purposes of the corporation are to provide a fellowship of relatives and friends of alcoholics to share their experience, strength, and hope in order to solve their common problems and to help others to do the same.

FIFTH: The corporation will be a membership corporation having one class of members. A current membership roster shall be kept by the Secretary of the corporation. Dues for membership shall be set by the Board of Directors.

SIXTH: The Board of Directors (Trustees) will be comprised of one information service representative (ISR) from each al-anon - alateen member group, the officers of the corporation, and committee chairpersons of the corporation. Only information service representatives shall be entitled to a vote as a member of the Board of Directors. The term of service for officers and directors shall be for one year, with each term to expire January 1 of each year.

SEVENTH: The street address of the initial registered office is 1524 Vista Avenue, Boise, Idaho, and the address of the initial

registered agent is Mary Jane Amsden.
