


- 2022 highest year of contributions in history of the organization!! \$3.3 mil




Idaho Contributions to WSO

- ✤ 69% of Idaho groups contributed
- Average amount donated for Idaho groups: \$177.13/yr.
- There are over 21,000 groups worldwide and while 100% of them use WSO services, only approx. 61% contribute to the WSO
- The 2023 average cost per group for WSO is \$321.25

Motion: to give conceptual approval to develop a comprehensive piece on sponsorship and service sponsorship using personal sharings.






Transforming Electronic Groups

- > 31 Areas have welcomed EMs into their service structure
- The Al-Anon.org website is replacing all paper transactions for updates and new physical meetings as well as EMs. It's faster, more accurate and confirmations will be sent via e-mail. Electronic Groups can register and transfer using the online forms
- Global Electronic Meeting Search
 - Live March 10, 2023
 - Driven by user's time zone
 - Listed in chronological order
 - Can search by name, platform, day, etc
 - Can print results
 - Registered Electronic Groups only, in Global Electronic Area (GEA)

Geographic Electronic Meeting Search

Work in progress

- Plan Use zip codes
- Put pin in map at water, park, intersection non-residence
- Color coded for physical groups and electronic groups
- For registered electronic groups in a geographic area



- What about temporary electronic groups??
 - 6 months to 1 year following area procedures passed (November 2022)
 - Consider what <u>audience</u> the group wants to attract and what <u>service structure</u> to participate in
- What about hybrid groups physical with an electronic component?
 - Can continue as long as group conscience decides

Questions

- *Most asked question has been "when do temporary Zoom meetings NEED to make a decision on where their group be officially located?
- Answer: ALL temporary Zoom meeting groups must move to an EM format, 6 to 12 months after the AREA decides to accept them.
- *If an EM wants to remain hybrid, there is no action that needs to be take. HOWEVER, to remain hybrid, the meeting must be attached to a physical location where a member will <u>physically be present and</u> <u>participate each and every week at that location</u>, in order to welcome newcomers. ONLY 1 Zoom/hybrid meeting may use that physical location address.

Policy Motion: Announcing Events


- Service Manual Pg 91-92
- Events hosted by or connected to the WSO, Area, District, Al-Anon Information Service (AIS)/Intergroup or one or more Al-Anon or Alateen groups can be announced at meetings.
- A.A. When Al-Anon participates through one of its service arms or a registered group in an A.A. even with speakers or workshops, these events may be announced at meetings.

Alateen

- Currently, 5 EMs are on the mobile app
- The long-term objective is to make EMs available for all Alateen members, insuring the safety of those members
- Scope: Evaluate the feasibility for expanding Alateen meetings online whether through the App or other platforms
- Concerns: US has less restrictive rules than international regarding age requirements, how many AMIAS sponsors are needed, vetting and more...
- Compliance must be addressed: How might this impact our area? Area must establish a process to support EMs. Internationals must work with their local offices and adhere to country laws.
- Does Idaho want to host Alateen EMs? If so, Idaho must develop and submit a process to WSO for approval.
- AMIAS: whose job will it be to "police out" moms and dads who want to sit in?
- Temporary Alateen meetings via Zoom will no longer be allowed in the future

Proposed Conceptual Solution -Electronic Alateen Groups

- All Electronic Alateen Groups would adhere to a set of minimum safety requirements - Global EASBR: Global Electronic Alateen Safety and Behavioral Requirements.
- Al-Anon Members Involved in Alateen Service serving Electronic Alateen Groups (AMIAS-E) would need to be mandated reporters
- AMIAS-E would need to pass a background check no felony, charge of child abuse or accusation of inappropriate sexual behavior
- At least two sponsors/AMIAS-E required at each meeting

More Electronic Alateen Group Feasibility

- Meeting links would not be published on public websites, only group info and group email
- Alateens must be 13 years COPPA (Children's Online Privacy Protection Act) is being updated
- Training would be provided for all AMIAS-E
- Areas would have the autonomy to decide whether to host Electronic Alateen Groups.
