D7 They have 10 meetings, and a strong outreach person. They have an Alateen meeting. They will sponsor a "Fall into Recovery" fundraiser for the Literature Center.

## Cheryl Sorenson's Delegate report: "Investing in Each Other to Preserve Our Legacy"

WSO is the business side of Al Anon, managing assets of 6 million dollars per year, and the Charter governs the AFG using bylaws. Between Delegates and Trustees, there are 91 voting members. 2/3 are Delegates, and 1/3 are Trustees and support staff. The Delegates vote on the seating motion of Trustees, making changes to the local service section of policy, the 2024 Annual Report, and the seating motion for the non-voting WSC participants.

Concept 6: The Administrative Responsibilities of Trustees. The 1984 Conference voted that the 1968 Concepts are AS IMPORTANT as the Steps and Traditions. Trustees are guardians of Al Anon's 12 Traditions, 12 Concepts of Service, and Al Anon World Service Conference. There are 9 Regions in the United States, and 2 in Canada. Idaho currently has no Regional Trustee.

There are 3 Delegates on each Conference Team. In 2026, WSC will return to a 5 day Conference in Newport News, Virginia.

2026 is the 75<sup>th</sup> Anniversary of AFG.

The Conference Leadership Team collects ideas, recommends topics, and gives review and feedback.

CAI= Conference Agenda Items.

These are used to gather, clarify, and consolidate.
